

s97B(5) TEMPLATE PAYMENT WITHHOLDING REQUEST

NOTICE TO CLAIMANT THAT RECIPIENT IS NOT A HIGHER PARTY

INFORMATION ABOUT THIS TEMPLATE

Section 97B(5) of the *Building Industry Fairness (Security of Payment)*Act 2017 provides that a person who is given a payment withholding request that is not the higher party, must notify the claimant within 5 business days of receiving the request that they are not the higher party.

Failure to do so is an offence and may incur a penalty.

WHO IS A 'HIGHER PARTY'?

If the claimant is a subcontractor — the person responsible for paying the respondent for the construction work (or supply of related goods and services) to which the unpaid adjudicated amount relates.

If the claimant is a head contractor—the person who finances the principal contractor or owner in relation to the construction work (or supply of related goods and services) to which the unpaid adjudicated amount relates.

A person or company is not a higher party if they no longer owe money to the respondent, have paid all amounts liable to be paid under the contract or the contract with the respondent is completed.

A payment withholding request cannot be given to higher party that is a resident owner.

COMPLETING AND GIVING THIS NOTICE

This template is to be completed by a person that has received a payment withholding request who is not the higher party to the respondent. It must be given to the claimant within 5 business days of receiving the payment withholding request.
